



## The Application and Regulation of Environmental Impact Assessment (EIA) and Strategic Environmental Assessment (SEA) in Hong Kong (83109)

*Environmental impact assessment (EIA) is an essential process to ensure the environmental factors are considered at all stages of project planning and development. In Hong Kong, the EIA Ordinance provides the legal framework for applying the EIA process to designated projects. With increasing public scrutiny and judicial review of several EIA projects, can Hong Kong keep pace with new developments in EIA? This 6-hour-long course aims to help the business sector keep abreast of essential knowledge of EIA and strategic environmental assessment (SEA) and related statutory requirements in Hong Kong.*
